



A Bidder can apply for all items listed at Para 1 or separately, as provided in the terms & conditions attached with the Bidding documents.
4. The successful Bidder will furnish performance guarantee which shall be 10% of the contract amount as specified under Rule 39 of Public Procurement Rules-2004.

TERMS AND CONDITIONS OF INVITATION TO BID

The terms and conditions of Invitation to Bid for procurement of velvet boxes, ribbons for military medals, (reduced size medals and miniature medals) engraving names on military medals and roundels, gold plating of Nishan-i-Imtiaz (Military) and Hilal-i-Imtiaz (Military) medals, silver plating of roundels of Nishan-i-Imtiaz (Military) and Hilal-i-Imtiaz (Military) and stitching ribbons on military medals (reduced size medals and miniature medals) by Section Officer D-25 (Medals) Ministry of Defence (Defence Division), Rawalpindi for **Current Financial Year 2022-23** are as under:-

1. The word **"Bid"** should be written in bold letters on single stage one envelope.
2. Complete address, CNIC, NTN certificate certified copy of Firm Registration Letter, FBR's GST Registration Number and certified copy of Professional Tax Certificate valid up to 30-6-2023 along with specimen signatures should be provided on the Printed Letter pad of the Firm.
3. Rates quoted by the Firm(s) will remain valid till 30-6-2023.
4. Sealed **"Bid"** should reach the undersigned on or before Thursday the 29th September 2022 at 1100 hrs alongwith samples of products. Bids will be opened in the presence of Bidders or their authorized representative(s) on 29th September 2022 at 1200 hrs in the Office of Chairman, Tender Committee for Opening and Evaluation of Bids, Ministry of Defence, Pak Sectt. No-II, Rawalpindi.
5. Samples of velvet boxes and ribbons are available with Ministry of Defence Section D-25 (Medals), GHQ Rawalpindi (Contact No.0306-9215279) for the Bidders.
6. The cost of the bid submission and samples will be borne by the Bidder.
7. On acceptance of **"Bid"**, a formal supply order for required number of items shall be placed with the successful Firm. **Final payment will be made after delivery of demanded items.**
8. Bid security in the form of Bank Draft valuing 3% of the Bid price on account of delivery of all items by the Firm in favour of Section Officer D-25 (Medals) GHQ, Ministry of Defence, Rawalpindi shall be deposited with the **"Bid"**. The Bid security of the unsuccessful Bidders will be returned on completion of necessary procedure.
9. It is the sole responsibility of the qualified Firm to supply the items with approved specifications within stipulated time. In case, it is found that items provided are of substandard quality, the Contract will be cancelled. Performance Guarantee will be forfeited and the Firm will be blacklisted.
10. Ministry of Defence reserves the right to accept or reject Bids in the light of Rule-33 of Public Procurement Rules-2004.
11. An affidavit to the effect that the Firm has never been indulged in any irregularity or litigation and has never been blacklisted by any Federal or Provincial Ministry, Division, Department or Organization etc, must accompany the Bid offer.
12. Provision of any false statement or document(s) may result in disqualification of the Bidder.
13. No change in the Bid will be accepted once a Bid is opened.
